DHL Express service includes pickup from your premises and delivery to the final destination, costs of customs clearance, costs of delivery to the forwarding agent and costs of rights, taxes and insurance.

Procedure to Follow:

1 • PICK-UP

To validate your DHL transport:

1/ Return the shipment form "Procedure to follow":

- by Fax 333.85.37.19.83
- or by e-mail:
infos@effervescents-du-monde.com

2/ You will receive a notification e-mail from DHL in order to confirm the shipment.

3/ Follow the instructions given in the e-mail to confirm the shipment.

In the following days, **Effervescents du Monde®** will charge you for the transportation cost, in accordance with **DHL/Effervescents du Monde®** special offer.
(See page 4 of the registration form).

2 • DUTIES

No importation duty is involved provided the bottle unit value is not more than **0.5 euros**. The pro-forma invoice (needless for EC shipments) and DHL Airbill must state the total value of your sample(s).

In case the value is higher, or if the shipment value exceeds **22 euros (22 USD)**, duties will be charged by France customs, and **Effervescents du Monde®** will add these extra charges to the transportation price.



Caution: Extra custom costs, taxes and duties will be charged if the value of your shipment exceeds 22 euros.

3 • PACKAGING

We strongly advise you to pack your bottles in polystyren boxes, which restrict the risk of breaking. Wooden boxes should not be used as there is a greater risk of damage. The invoice will be issued according to the weight indicated on the shipment.



Caution: shipment charges are based on either volumetric weight or actual weight, whichever is greater.
(see the example on page 4 of the registration form).
